**INFORMATION ABOUT THE EARNINGS STATEMENT
SECTION OF YOUR PAYCHECK**

- A** - Earnings: All earnings Including reimbursements and benefits (Vacation Leave, Sick Leave, Holidays, etc.)
- B** - Benefits Deductions: 401(k) plus Health, Dental, Vision, and eFlex deductions
Note: Health, Dental, and Vision are combined and can be shown as regular deductions or as "Flex" Pre-Tax deductions.
EF (Flex) or EE (Non Flex) is Employee's portion. DF (Flex) or Dep Ins (Non Flex) is Dependent's portion.
- D** - Regular Deductions: All deductions other than "B" Benefits deductions
- DD** - Direct Deposit: "Ck" = Checking Account (Deposit) with last 5 digits of Account Number
"Sv" = Savings Account (Deposit) with last 5 digits of Account Number
- E** - Current Totals: Earnings and hours this pay period and YTD (includes non taxable reimbursements)
- H** - Total of all Hours paid Year-To-Date (YTD)
- N** - Net Pay after all deductions and taxes are deducted. If Net Pay = "0.00", either there is a Direct Deposit, or if no Direct Deposit, then the sum of all deductions subtracted from Gross Pay could show Net Pay as "0.00" (if deduction total is large enough)
- T** - Total Year-To-Date W-2 Wages (YTD Gross Wages minus 401(k) and "Flex" Pre-Tax deductions)
- TD** - Total Deductions (this check): All deductions this pay period labeled "B", "D", "DD"
- W** - Federal Withholding Tax deductions
Under "FED. W/H" block, "S" is Single + "00" = no exemptions. ("M" would indicate Married + number of exemptions)
Federal = Withheld tax according to your W-4
FICA O = Withheld for Social Security (Fed. Taxable YTD wages + 401(k) deductions-to-date X 6.2% up to \$87,000 for 2003 (percent and maximum dollar amount are subject to change each year)
FICA M = Withheld for Medicare (Fed. Taxable YTD wages + 401(k) deductions-to-date X 1.45%)

Note: "Deductions" section can only list 20 items. All items in excess of 20 will be totaled and shown as "Other".
Important Information for Direct Deposit Recipients: Always carefully review your paycheck and check stub. Occasionally circumstances may require the issuing of an actual paycheck rather than the usual Direct Deposit of your pay.
