Health, Dental, Vision, & Voluntary Insurance Plans

Teladoc

Teladoc is an added medical benefit offered at no additional cost to employees enrolled in one of the non-HSA Florida Blue Plans. There is a small co-pay for employees enrolled in a HSA eligible Florida Blue Plan (BlueOptions 03160/03161 and BlueCare 128/129). The Teladoc program will extend to immediate family members even if not enrolled in the health plan. For more information, visit www.teladoc.com.



Flexible Spending Account Plan and Cafeteria Plan

We offer a "cafeteria" type benefit plan, which includes employee paid pre-tax premiums for group health, dental, vision and some other qualified insurance plans. Employer-optional plans also offer pre-tax treatment of out-of-pocket medical expenses and childcare expenses.



Employee Savings Plan

Eligible employees may enroll in payroll deduction for an Individual Retirement Account (IRA).



Direct Deposit of Payroll Checks

We offer free electronic transfer of payroll checks into any bank or credit union that is a member of the Federal Reserve System. This ensures timely deposit of payroll checks, so you don't have to worry about the mail service or trips to the bank to make the deposit yourself.



Employee Assistance Program

Tuition Reimbursement/Rewards

Employees who have completed one year of full-time service with LandrumHR are eligible to receive reimbursement of 50% of college tuition up to \$500 per year. Courses taken must be job-related and approved in advance.



Employees enrolled in our Guardian Dental plan can earn up to \$2,000 Tuition Rewards annually and a bonus in year 4. Rewards may be used at SAGE Scholar Colleges. The plan provides up to \$17,000 in tuition discounts over the first 4 years of college.



Travel and Entertainment Discounts

Employees may take advantage of travel and entertainment discounts at participating theme parks, cruises, rental cars, movie theaters, hotels, sports events, and health clubs. Through our corporate discount program, TicketsAtWork, you have the opportunity to purchase discount tickets year round. Tickets must be ordered prior to your trip and will be mailed directly to you. Adoption Assistance

Employees who have completed one year of full-time service with LandrumHR, and who adopt a child through a state licensed agency, may be reimbursed up to \$500 for legal fees incurred in that adoption (one adoption reimbursement per family). Step-children and grandchildren do not qualify.
